Procedures for membership are as follows: 1) Complete & sign application, 2) Submit application with check/cash to the address below for consideration by the Board of Governors, 3) **After recommendation by the BOG**, attend three (3) organized functions, and receive a Safety Briefing from an authorized Safety Officer. **These steps must be completed during the first 90 days following recommendation by the BOG.** After completion of these steps and if your application is approved by the membership at the next membership meeting, keys to the facility will be issued. If approved by the membership the one (1) year probationary membership will begin from the date of recommendation by the BOG. Membership may be terminated in accordance with the club Bylaws.

____(1) Complete/sign application – fill it all out. Sponsor's Name/phone# _____.

____(2) Submit app with dues (check/cash) to your Sponsor or a Board of Governor (BOG) member.

a. Dues are \$125 per calendar year, prorated depending on the month joined. Jan – Mar = \$125; Apr – Jun = \$100.00; Jul – Oct. = \$75.00; Nov – Dec = \$125.00 (Counts as next years dues.)

b. Your app is brought before the BOG and a vote taken to give/not give you a temp 90 day temporary membership to fulfill the rest of the application.

c. If the temp 90 day membership is given, your app will be posted on the bulletin board in the clubhouse for all members to view and it will be announced in the Quarterly Newsletter.

d. During the 90 day period you must attend three scheduled events held by HCGC and get your Safety Brief signed off. This is to allow members to meet you, and eventually vote for or against your admittance into the club. As you attend the scheduled events you must get your app signed by a club member. Your app will be posted on the bulletin board in the clubhouse. **Failure to complete these steps with in the 90 day timeframe will result in you application being voided and you will be required to resubmit a new application and restart the application process.**

e. **Scheduled Events:** Weekly - Tuesday - Skeet, Thursday - Trap

Monthly- 1st Saturday - Open

- 2nd Saturday - IDPA pistol (Monthly)

- 3rd Saturday – Benchrest Rimfire (Seasonal)

- 3rd Saturday – 3 Gun (Monthly)

- 4th Saturday - High Power Rifle (Seasonal)

- 4th Saturday – Vintage Sniper Rifle

- 1st Monday - BOG Meetings (except holidays)

Quarterly - Membership Meeting after BOG Meetings in Jan, Apr, Jul and Nov.

____(3) If the above requirements are completed within the 90 day period then, at the first Quarterly Membership Meeting after completing the requirements your app is brought before the membership where it is voted on for admittance or rejection. **Suggestion: Be at the meeting.**

____(4) If approved by the members, keys and a probationary (red) membership card are issued and you are given a one year probationary membership from the beginning date of the 90 day temporary membership.

____(5) After the one year probationary period you will be notified by the Secretary and are again voted upon by the membership. If accepted, you receive a General Membership and voting privileges. **Suggestion: Be at the meeting.**
