Special Membership Meeting, September 14th, 2020

Special Membership Meeting: Called to Order at 1902

New Business:

The "Safety Wall" on the pistol berm which was approved by the General Membership in the July meeting, significantly exceeded the verbal estimate of \$5,500 by a little over \$4,300. An explanation of the cost overrun was presented to the membership.

A majority of the membership present at the meeting voted to approve the additional expense.

Suggested changes to the Bylaws were recommended by the Board designed to prevent this from happening in the future and will be refined further and finalized in the October meeting. The Amendment change will then be distributed to the Membership in preparation for a vote during the November General Membership meeting.
