**BOG-approved via email vote:** \$400 for High Power on glue, targets, e-target cables, duct tape, \* misc. \$250 on cardboard targets & pasters for HC Sport Handgun. Reconfirmed \$1000 additional to cover sales tax and lift rental installation of the LED lighting for Trap Field #1. \$100 for rip rap to cover the area on the left side of the front drive.

# Summer trap league

## Rules for summer trap league

1. Shooting will start the first week of April and go for 26 weeks
2. We will shoot for score one round each week either the weekday shoot, or the following weekend shoot and no weeks can be made up the following week.
3. Only the highest 20 scores will be totaled for final score, therefore, no shooter will be penalized for missing a few weeks.
4. All shooters that shoot more than 20 rounds their lowest scores will be thrown out.
5. All shooters MUST declare their scoring round prior to their first shot of that round.
6. Cost for each shooter will be \$20 for the year plus you must still pay the club for your round.
7. Entire entry fee MUST be paid prior the shooting the first round.
8. Prizes at end of competition will be as follows:
  - 4 or 5 paid shooters-first place only.
  - 6-7 shooters-1<sup>st</sup> 60%, 2<sup>nd</sup> 40%.
  - 8 or more shooters- 1<sup>st</sup> 50%, 2<sup>nd</sup> 30% and 3<sup>rd</sup> 20%.
9. If any FULL week of shooting is cancelled due to weather or other unavoidable reasons we will continue until all 26 weeks have been shot.
10. As we get our lights up the weekday shoot or the weekend shoot may be in the evening, however, we will start shooting before dark so those shooting for score on those days MUST shoot their round before lights are on to be fair to shooters that are not able to shoot under lights.
11. Ties at end of season will be decided by sudden death shoot off from the 27-yard line.

**Note:** Shooters will keep their own scores. When a bird is lost, please keep that empty hull separate or use some other method to keep track of the score for that round.

# New Club-member SPONSORSHIP

All Henry County Gun Club Membership applications require a **SPONSOR or BOG MEMBER** to be named as part of the application process.

The named **SPONSOR or BOG Member** is responsible for helping the new applicant understand the process. That person will make sure the new applicant records attendance of 3 Club Events and Safety Brief on the application and Safety Brief document.

These actions must be completed before the applicant will be eligible for a Probationary Vote at a MEMBERSHIP meeting which is only held 4 times per year: **January; April; July & November**. When voted in as Probationary member, they will receive membership card and key to the front gate & Clubhouse side-door.

One year after the BOG-approval date, the Probationary Member is then automatically eligible for the SECOND Membership Vote for FULL Membership, no further action required.

If an application (with payment) comes in without a named sponsor, a BOG member will be designated as the applicant's Sponsor and will guide the applicant through the process.
