Procedures for membership are as follows:

- 1) Complete, Sign, and Submit, the application with check/cash to either the address below or turn into any Board of Governors Member.
- 2) **After the BOG has voted to recommend your Temporary Membership**, attend three (3) scheduled events, and receive the Safety Briefing from any Board of Governors Member. **These steps must be completed during the first 90 days following recommendation by the BOG.**
- 3) After completion of these steps, your application is voted for approval by the General Membership at the next membership meeting. If approved by the membership the one (1) year Probationary Membership will begin from the date of recommendation by the BOG, and keys to the facility will be issued. Membership may be terminated in accordance with the Club Bylaws.

- ____(2) Submit application with dues (check #_____/cash) to your Sponsor or Board of Governors (BOG) member.
- a. Dues are \$125 per calendar year, prorated depending on the month joined. Jan – Mar = \$125; Apr - Jun = \$94
Jul – Sep. = \$63; Oct – Dec = \$32
 - b. Once received by the BOG, they will vote whether to grant you a Temporary Membership of 90 days in order to complete and fulfill the remainder of the application.
 - c. If the Temporary Membership is given, your application will be posted on the bulletin board in the clubhouse for all members to view and it will be announced in the Quarterly Newsletter.
 - d. **During the 90-day period you must attend three scheduled events held by HCGC and receive your Safety Brief by a BOG member.** This is to allow members to meet you, and eventually vote for or against your admittance into the club. As you attend the scheduled events you must get your checklist (this document) and your application signed by an Event Director. Your application will be posted on the bulletin board in the clubhouse. **Failure to complete these steps with in the 90-day timeframe will result in your application being voided and you will be required to resubmit a new application and restart the application process.**
 - e. **Scheduled Events:** Any event posted in the Club Calendars on the Club's website at www.henrycountygunclub.com
Is open for attendance and can be signed off by the Match/Event Director or any Club Member. Weekly there are Skeet and Trap events and monthly every Saturday there are multiple events available for attendance, check the calendar for the latest information.

(3) If the above requirements are completed within the 90-day period then, at the first Quarterly Membership Meeting, (January, April, July, and November) after completing the requirements your application is brought before the membership, where it is voted on for admittance or rejection. *****Suggestion: Try to be at the meeting for your Probationary Membership vote.**

____(4) If approved by the members, a Probationary (red) Membership card and Key are issued, and your one-year Probationary Membership begins from the date of the 90-day Temporary Membership.

____(5) After the one-year probationary period you will be notified by the Secretary, and the General Membership will vote on your admittance or rejection into General Membership. If accepted, you receive a General Membership card and voting privileges.

Suggestion: Try to be at the meeting for your General Membership vote.
